To Whom It May Concern:

**Atlántida S.A.** a has commissioned SCS Global Services to conduct an RSPO Initial Certification Assessment of its palm oil mill and supply base located near Kilómetro 262, Carretera a Ocós, Tecún Umán; San Marcos, Guatemala. The assessment will be conducted of 1 Palm Oil Mill and 1 Estate.

SCS Global Services plans to conduct the Certification assessment of **Atlántida S.A.** from **30 August to 03 of September 2021.** The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the National Interpretation (NI) of the RSPO Principles and Criteria 2018 for Guatemala for the Production of Sustainable Palm Oil. Endorsed by the RSPO BoG on the 10<sup>th</sup> June 2021.
