To Whom It May Concern:

Société Camerounaise de Palmeraies (SOCAPALM) Mbambou of Cameroun a has commissioned SCS Global Services to conduct an RSPO Certification Assessment of its palm oil mill and supply base located near 25 km de la RN3, Douala Yaounde, Littoral Province, Cameroun. The assessment will be conducted of 1 Palm Oil Mill, and 1 Oil Palm Plantation.

SCS Global Services plans to conduct the Certification assessment of the **Société Camerounaise de Palmeraies** (SOCAPALM) Mbambou mill from 25-29 January 2021. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018), with updated Supply Chain requirements for Mills.

The assessment will cover legal, environment, economical, workers' health and safety, and social aspects as required by the RSPO Principles & Criteria. Below is general information related to the certification unit.
