<u>Public Notification on Upcoming RSPO Re-certification Assessment of PT Rimba Mujur Mahkota, Sikarakara Village, Natal Sub-District, Mandailing Natal District, North Sumatera Province, Indonesia.</u>

PT Rimba Mujur Mahkota has applied to PT TUV Rheinland Indonesia for Re Certification Assessment against the RSPO and Supply Chain. Re-certification assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

PT Rimba Mujur Mahkota is a member of the RSPO (RSPO Membership Number: 1-0124-12-000-00 & Palmtrace Member ID No. : RSPO\_PO1000001960) and has been actively involved in every international conference held by the RSPO.

## Scope of assessment:

The RSPO Re certification assessment of PT Rimba Mujur Mahkota is scheduled to commence from **5**<sup>th</sup> **– 9**<sup>th</sup> **August 2019.** The assessment shall be carried out for 1 palm oil mill and 2 palm oil plantations in Sikarakara Village, Natal Sub District, Mandailing Natal District, North Sumatera Province.
