RSPO Initial Certification Audit of Plantations Socfinaf Ghana (PSG) Ltd. PSG Palm Oil Mill, Socfin S.A (RSPO Membership : 1-0269-19-000-00

Dear Stakeholders,

This is to inform that the above Management Unit under the Parent Company of Socfin S.A with RSPO membership number: 1-0269-19-000-00 had appointed CB PT. TUV Rheinland Indonesia to conduct the [Initial Certification] Audit Plantations Socfinaf Ghana (PSG) Ltd. PSG POM and its supply base, located at Socfinaf Street, Daboase Community, near Takoradi Wassa East District, Western Region. The audit will be conducted from June 11<sup>th</sup> to 14<sup>th</sup> 2022 against the requirements of Ghana National Interpretation of the RSPO Principle and Criteria 2019.

RSPO Palmtrace ID number of the Mill is RSPO\_PO1000011381.

Plantations Socfinaf Ghana (PSG) Ltd.'s vision is responsible tropical agriculture. The Company operates in agriculture industry specializing in oil palm and rubber industry. PSG's total oil palm plantations cover 7081.7 ha, sourced from its own two estates Manso and Subri (respectively 910.67 ha and 17'242.19 ha). Currently, PSG has no smallholder/outgrower scheme. PSG will undergo an initial certification for its Manso Estate, while later adding the Subri Estate as scope extension.
