Invitation to comment on RSPO Certification Assessment of PT Umbul Mas Wisesa – Labuhan Batu Selatan, North Sumatera Province, Indonesia.

PT Umbul Mas Wisesa, a wholly owned company by S.A Sipef N.V of Belgium, has applied to BSI for RSPO Certification of its palm oil mills and supply base.

PT Umbul Mas Wisesa project covers a total planted area of 8,100 hectares from 8,900 hectares concession area, in three company-owned estates. The company owns and operates 1 (one) newly-built Crude Palm Oil Mills located in Labuhan Batu Selatan Regency, North Sumatera Province. The new Mill is receiving the FFB only from company plantations.

BSI plans to conduct certification during the week of 12th May 2014.
