**Invitation to comment on RSPO Re-Certification Assessment of Pamol Plantations Sdn Bhd, Pamol Kluang Oil Mill – Kluang, Johor, Malaysia.**

Pamol Plantations Sdn Bhd, a subsidiary of IOI Corporation Berhad, has appointed BSI to conduct RSPO Re-certification assessment of its Pamol Kluang Oil Mill and supply base. The assessment will be conducted in 1 Palm Oil Mill and 6 Oil Palm Plantations which are managed by the company. The company is located at 8 ½ Miles, Jln. Mersing, 86007 Kluang, Johor, Malaysia.

BSI plans to conduct re-certification assessment of Pamol Kluang Oil Mill on 6th to 9th Jan 2015. The assessment will be conducted based on the RSPO P& C 2013, Malaysian National Interpretation: MY-NIWG: (MYNI 2010), RSPO Supply Chain for CPO Mills, Module D – Segregation: 2011. The assessment will also start to evaluate the company’s implementation on new RSPO Principles and Criteria for the Production of Sustainable Palm Oil: 2013. The assessment will cover legal, environment, economical, workers’ health and safety, and social aspects as required by RSPO P&C.
