In ICA Sweden "Brand criteria" for all food products include demands on CSPO, from segregated supply chains. At RIMI Baltic (also within ICA Gruppen) the target is 100% CSPO through physical supply chains in own brand products by 2020. Already though, almost all of the palm oil used in the own brand food products at RIMI Baltic is CSPO through physical supply chains (MB & SG) and the work continues. Reporting for all OpCos within ICA Gruppen will follow in coming years, this year reporting only includes ICA Sweden food products.
