Customers do not want to pay for RSPO products. Actually we are using a blend of PO and POS. The cost for making the blend RSPO MB/SG is to high (+- \leq 85/ton). We are planning to do some tests in production to be able to use normal PO. (extra cost for RSPO +- \leq 15 - \leq 30/ton)
