	Background	
	The MPOA had a sustained objection to the proposed HCV Compensation Procedure which halted further progress on the development on said procedure and halted the Malaysian National Interpretation of the RSPO P&Cs.	
2.1	The BoG was briefed that, since November 2013, several unsuccessful attempts have been made to secure an appointment with the CEO of MPOA, to discuss the 10 requests that they had made in relation to the Compensation Procedure. The assigned RSPO taskforce finally met with the CEO of MPOA on the 22 nd of January 2014.	
	The meeting did not yield any new results except to reinforce MPOAs sustained objection.	
	Decision:	
	DW to officially inform MPOA on RSPOs willingness to address two out of the 10 requests made by MPOA, which are, the Legal and Financial elements of the request list.	
	On the legal elements:	

RSPO will work to provide language that will not put growers in a position where it is becomes an automatic admission of guilt, if they agree to compensate.	
On the finance element:	
RSPO had previously engaged consultants to analyse financial implications of the HCV Compensation Procedure and it's results was previously agreed by the members of the Compensation Taskforce.	
However, since MPOA continues to see this as an issue, the RSPO invites MPOA to conduct its own study on these financial impacts which could be then submitted to the Compensation Taskforce for review.

 The RSPO will also : Request MPOA reply officially to the RSPO response, stating their agreement/objection, by the 10th of February. Request MPOA to act in good faith towards the solution of this problem. Inform MPOA that failure to reply to the RSPO within the set deadline allows the board of governors to exercise it's prerogative to request MPOA to reconsider its position on the BoG.
