1.0	Chair of the meeting BW could not attend the meeting at the last moment as he had issues connecting to the meeting line. He however, recommended for either AH or TS to chair the meeting in his absence.	
	TS kindly volunteered to chair the meeting.	
2.0	Renaming Secretary General role to CEO	
	The BoG was briefed by DW on the reasoning behind the proposal. The brief was based on the decision paper that was sent prior to the board meeting (see annex 1).	
	Decision:	
	It was unanimously agreed for the BoG to submit a resolution, to amend the current statutes reflecting the renaming of the role of Secretary General to Chief Executive Officer. This resolution is to be presented to the membership at GA12.	
	DW will draft the resolution on the BoG's behalf.	DW
1.0	A.O.B Venue for RT13 There has been some concerns expressed by BoG members, members and secretariat staff on the viability of Bangkok remaining a venue for RT13 given the bombings that has happened in the last week.	
	 Options outside of Thailand are presently limited and because of the short time frame, the options considered will only be in Malaysia. DW listed the options as per Annex 2. There will be penalty imposed on the RSPO if there was a cancellation. However, the penalty may be minimised or avoided if a hotel from the same chain is used in this alternative venue. 	
	MB mentions that several countries have come out with travel advisories and that he and 2 others, at present, cannot get approval to attend RT13 if it's based in Bangkok. The other board members are unaware if organisational restrictions exists (or not) in attending RT13 in Bangkok.	
	JV will seek feedback from his colleagues in Thailand, for their assessments of the situation. DW will seek feedback from JC. BV suggests that the secretariat takes the decision since it will be the secretariat who will be doing most of the work for the RT.	
	Decision:	
	TS suggests that more information should be obtained from JV, JC and the secretariat. This information should help the secretariat make a recommendation to the BoG by 28 th September.	
	TS also comments that it would make sense, if the decision is to move location, to choose a Shangri-La in another city. This will help minimise the potential penalties that we will have to pay Shangri-La Hotel in Bangkok.	

AGENDA ITEM: Renaming from Secretary General to CEO

Background

The Board of Governors have committed, on numerous occasions, move more of the executive functions to the RSPO Secretariat. This has been happening in a gradual manner over the last years.

One of the more overt public signals of this shift, is the renaming of the RSPO "Executive Board" to the RSPO "Board of Governors". It sent a clear signal to all stakeholders, the intentions of the board.

It was during this period of discussing the renaming of the, then Executive Board, that a proposal was made for the Secretary General's role to be renamed as CEO. The proposal was rejected as there was a single objection from a board member.

2.0 Action requested from the Board of Governors

In the discussions on renewal of his contract, the incumbent SG requests the BoG to revisit this proposal of renaming the Secretary General position to CEO. It completes the original intent and it shows progress of the Board in this process of transition.

Some notes that may help clarify popular questions:

- 1. Many reputable and large non-profits use the term CEO.
- 2. The authority/"powers" of the SG/CEO does not change
