A feature of the Univanich business is that the company's own plantations, of 6,000 ha, produce less than 20% of the FFB processed by the company's three crushing mills. More than 80% of the FFB is purchased from independent small farmers. The Univanich Oil Palm Research Center, in Krabi Province, is Thailand's main centre for oil palm agronomic research, advanced palm breeding and oil palm tissue culture. Univanich DxP hybrid seeds are currently exported to growers in more than ten countries.
