## Notification on RSPO Certification Assessment of EXTRACTORA EL ROBLE S.A.S Palm Oil Mill and its Estates supply base.

**EXTRACTORA EL ROBLE S.A.S, RSPO** Membership number: 1-0170-14-000-00, has applied to PT SGS Indonesia to conduct RSPO P&C Certification assessment for one of their management unit in Colombia.

The Certification Assessment scope is EXTRACTORA EL ROBLE S.A.S Palm Oil Mill and its Estates supply bases, located in Zona Bananera, Colombia against the requirement of Colombian National Interpretation of the RSPO 2013 Principles and Criteria for the Production of Sustainable Palm Oil (September 2016); and the requirements of RSPO Supply Chain Certification Systems (SCCS) – November 2014, for Palm Oil Mill – Module E: Mass Balance.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 24 – 27 January 2017
