Notification on RSPO Initial Assessment of Genting Plantations Berhad – Genting Trushidup Oil Mill and its supply base.

Dear Stakeholders,

Genting Plantations Berhad, RSPO Membership number: 1-0086-06-000-00, has applied to PT SGS Indonesia to carry out RSPO P&C Certification assessment.

The Certification Assessment scope is Genting Trushidup Oil Mill and its supply base, located in Sabah, Malaysia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) MY-NI 2014 in conjunction with RSPO Certification System (June 2017); and the RSPO Supply Chain Certification Standards and Systems (SCCS) 2014 for Palm Oil Mill – Module E: Mass Balance in conjunction with RSPO Supply Chain Certification Standard and System (Revised June 2017).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 25th – 29th September 2017.
