Kwantas Corporation Berhad, RSPO Membership number: 1-0150-14-000-00, has applied to PT SGS Indonesia to carry out RSPO P&C Certification assessment.

The Certification Assessment scope is Haranky Palm Oil Mill and its supply base, located in Kinabatangan, Lahad Datu – Malaysia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) MY-NI 2014 and the RSPO Supply Chain Certification Systems (SCCS) 2014 for Palm Oil Mill – Module E: Mass Balance.
