PT Perkebunan Nusantara II has applied to Mutuagung Lestari and will conduct Initial Certification with scoped Kwala Sawit POM and its supply based, located at Namo Sialang Village, Batang Serangan Sub District, Langkat District, Sumatera Utara Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Perkebunan Nusantara II has successfully been registered in the PalmTrace IT platform with member RSPO_PO1000007585. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 1 (one) estates on 13 to 17 November 2023.


