Golden Agri Resources has applied to Mutuagung Lestari and will conduct Re-Certification at PT Binasawit Abadipratama with scope Sungai Rungau POM and its supply based, located at Rungau Raya Village, Danau Seluluk Sub District, Seruyan District, Kalimantan Tengah Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Sungai Rungau POM – PT Binasawit Abadipratama has successfully been registered in the PalmTrace IT platform with member RSPO\_PO1000001155. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 5 (five) estate on 12 – 17 June 2023.
