Notification of RSPO Recertification of Pembangunan Raya POM PT Agro Sejahtera Manunggal subsidiary of Bumitama Agri Ltd (RSPO Membership 1-0043-07-000-0, 08 October 2007)

Dear Stakeholders.

Bumitama Agri has applied to Mutuagung Lestari and will conduct Recertification at PT Agro Sejahtera Manunggal with scope Pembangunan Raya POM and its supply based, located at Kendawangan Sub District, Ketapang District, Kalimantan Barat Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Pembangunan Raya POM – PT Agro Sejahtera Manunggal has successfully been registered in the Palm Trace IT platform with member RSPO_PO1000004866. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, 5 (five) estates on 26 February to 03 Maret 2024.

PT Agro Sejahtera Manunggal and PT Gunajaya Harapan Lestari didn't carried out NPP Process.



As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
