Seumanyam POM – PT Socfin Indonesia has applied to Mutuagung Lestari and will conduct re-certification located in Tanjung Simpang Deli Kilang Village, Darul Makmur Sub-District, Nagan Raya District, Aceh Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Seumanyam POM – PT Socfin Indonesia has been register on PalmTrace IT platform with member ID RSPO\_PO1000001777. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to Seumanyam POM – PT Socfin Indonesia on **14 to 19 September 2020**.
