**Notification on RSPO Re-Certification of Mustika POM – PT Sajang Heulang a subsidiary of Sime Darby Plantation Sdn.Bhd (RSPO Membership 1-0008-04-000-00, 07 September 2004)**

Dear Stakeholders,

Sime Darby Plantation Sdn. Bhd has applied to Mutuagung Lestari for RSPO annual surveillance to Mustika POM – PT Sajang Heulang (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Sub District of Kusan Hulu, Sungai Luban and Kuranji, District of Tanah Bumbu, Province of South Kalimantan Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014, Revised 14 June 2017.

Sime Darby Plantation Sdn. Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd has been registered since September 7, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the Re-Certification of Mustika POM – PT Sajang Heulang which has 1 (one) mill and 4 (four) estates on **04 to 09 May 2018**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
