Public Notification on Upcoming RSPO Recertification Assessment of PT Socfindo Kebun Seunagan, Sawit Seunagan POM, Kuala Pesisir Sub-District, Nagan Raya District, Aceh Province, Indonesia.

PT Socfindo Kebun Seunagan, Sawit Seunagan POM has applied to PT TUV Rheinland Indonesia for Recertification Assessment against the RSPO P&C and Supply Chain. Recertification Assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by Indonesia National interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020)

PT Socfindo Kebun Seunagan is a member of the RSPO (RSPO Membership Number: RSPO: 1-0269-19-000-00 & Palmtrace Member ID No. : RSPO_PO1000001774) and has been actively involved in every international conference held by the RSPO.

Scope of assessment:

The RSPO Recertification assessment of PT Socfindo Kebun Seunagan, Sawit Seunagan POM is scheduled to commence from **October 5th – 9th 2020** with onsite audit.
