Notification on RSPO Initial Certification Assessment of PT Tanjung Sawit Abadi – Tanjung Sawit Abadi Palm Oil Mill and Its Supply Base

Date: 22nd June 2019

Dear Stakeholders,

PT TANJUNG SAWIT ABADI (RSPO Membership number: 1-0111-07-000-00 PT Sawit Sumbermas Sarana) has applied to PT SGS Indonesia to conduct RSPO P&C Initial Certification Assessment for one of their management Unit i.e. Tanjung Sawit Abadi Palm Oil Mill and its supply base.

The Initial Assessment scope is Tanjung Sawit Abadi Palm Oil Mill and 3 (three) company own estates as supply bases located at Lamandau District, Central Kalimantan – Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C 2013) Indonesian National Interpretation INA-NI (2016) in conjunction with RSPO Certification System (June 2017); and the RSPO Supply Chain Certification Standards and Systems (SCCS) – Module E: CPO Mills Mass Balance in conjunction with RSPO Supply Chain Certification Standard and System (version 24 November 2014 Revised 14 June 2017).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on **22 – 27 July 2019**.
