Notification on RSPO Re-certification Assessment of PT Indo Sawit Kekal – River View Mill and Its Supply Base

Dear Stakeholders,

PT INDO SAWIT KEKAL - RIVER VIEW MILL (RSPO Membership number: 2-0215-11-000-00 a subsidiary of Cargill Incorporated; RSPO Palm Trace Member ID: RSPO_PO1000002360) has applied to PT SGS Indonesia to conduct RSPO P&C Recertification Assessment for one of their management Unit i.e. Indo Sawit Kekal - River View Mill Palm Oil Mill and its supply base. This unit holds RSPO certificate number SGS-RSPO/PC17-00001 valid thru 21 December 2019.

The Recertification Assessment scope is River View Mill, 2 (two) Estates and 2 (two) KKPA Scheme Smallholders as supply bases located at Desa Danau Buntar, Kecamatan Kendawangan, Kabupaten Ketapang, Kalimantan Barat Province, Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C 2013) Indonesian National Interpretation INA-NI (2016) in conjunction with RSPO Certification System (June 2017); and the RSPO Supply Chain Certification Standards and Systems (SCCS) 2014 for Palm Oil Mill - Module E: Mass Balance in conjunction with RSPO Supply Chain Certification Standard and System (Revised June 2017).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 26 - 30 August 2019.
