Notification on RSPO Re-certification Assessment of PT Austindo Nusantara Jaya Agri, Binanga Palm Oil Mill and Its Supply Base

Dear Stakeholders,

PT Austindo Nusantara Jaya Agri (RSPO Membership number: 1-0032-07-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Re-certification assessment for one of their management Unit i.e. Binanga Palm Oil Mill and its supply base which hold valid RSPO Certificate number 82450217057, valid thru 13 November 2017.

The certification assessment scope is Binanga Palm Oil Mill and 3 (three) company owned estates, located at Simangambat Subdistrict, Padang Lawas Utara District, North Sumatera Province, Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C 2013) Indonesian National Interpretation INA-NI (2016) and the RSPO Supply Chain Certification Systems (SCCS) 2014 for Palm Oil Mill – Module E: Mass Balance.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 21-25 August 2017.
