## Notification on RSPO Recertification Assessment of PT Hindoli – Sungai Lilin & Tanjung Dalam Palm Oil Mills and its Supply Base

Date: 28 December 2018

Dear Stakeholders,

PT Hindoli (RSPO Membership number: 2-0215-11-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Re-certification Assessment for their management Unit i.e. Sungai Lilin and Tajung Dalam Palm Oil Mills with their supply bases. These Mills and supply bases have been previously hold a RSPO certificate (#SGS-RSPO/PC18-00014), with due expiry on 24th February 2019.

The Assessment scope is Sungai Lilin and Tajung Dalam Palm Oil Mills with three (3) company owned estates and 12 Cooperatives of scheme smallholders as supply bases located at Musi Banyuasin District, South Sumatera Province – Indonesia; against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C 2013) Indonesian National Interpretation INA-NI (2016) in conjunction with RSPO P&C Certification System (14 June 2017) and the RSPO Supply Chain Certification Standards and Systems (Revised 14 June 2017) for Palm Oil Mill – Module D: Identify Preserved.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirements for all its production. PT SGS Indonesia has planned to conduct the Re-certification Assessment on **28 January 2019 to 2 February 2019**.
