Notification on RSPO Recertification Assessment of PT Kresna Duta Agroindo - Langling Palm Oil Mill and Its Supply Base

PT KRESNA DUTA AGROINDO - LANGLING PALM OIL MILL (as a subsidiary of Golden Agri-Resource Ltd; RSPO Membership number: 1-0096-11-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Recertification Assessment for one of their management Unit i.e. Langling Palm Oil Mill and its supply base. The company holds RSPO certificate number RSPO 00007 valid until 17th August 2019.

The Recertification Assessment scope is Langling Palm Oil Mill and one estate as supply base located at Bangko Estate Division 5 located at Langling village, Bangko sub-district, Merangin District, Jambi Province, Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C 2013) Indonesian National Interpretation INA-NI (2016) in conjunction with RSPO Certification System (June 2017); and the requirements of Module E: Mass Balance for CPO Mills of RSPO Supply Chain Certification Standard and System (21 November 2014 Revised 14 June 2017).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 27-29 June 2019.
