## Notification on RSPO Recertification Assessment of PT. Supra Matra Abadi – Aek Nabara Mill and It Supply Base

PT. Inti Indosawit Subur (RSPO Membership number: 1-0022-06-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Recertification Assessment for one of their management Unit i.e. PT. Supra Matra Abadi - Aek Nabara Mill and Supply Bases (RSPO Palm Trace number: RSPO PO1000002145). This management unit holds valid RSPO P&C certificate SGS-RSPO/PC19-00021 until 5 March 2020.

The Recertification Assessment scope is PT. Supra Matra Abadi - Aek Nabara Mill and Supply Base, 1 (one) Estate as supply base located at S1-S3 / Sukadame Village, Bilah Hulu District, Labuhan Batu Regency, North Sumatera, Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) 2018 in conjunction with RSPO Certification System (June 2017).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 24-28 February 2020.
