Notification on RSPO Recertification Assessment of PT. Supra Matra Abadi - Teluk Panjie Mill and Its Supply Base

PT. Inti Indosawit Subur (RSPO Membership number: 1-0022-06-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Recertification Assessment for one of their management Unit i.e. PT. Supra Matra Abadi - Teluk Panjie Mill and Supply Bases (RSPO Palm Trace number: RSPO_PO1000002146). This management unit holds valid RSPO P&C certificate SGS-RSPO/PC19-00022 until 20 April 2020.

The Recertification Assessment scope is PT. Supra Matra Abadi - Teluk Panjie Mill and Supply Base, 1 (one) Estate as supply base located at Teluk Panjie Village, Kampung Rakyat District, Labuhan Batu Regency, North Sumatera, Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) 2018 in conjunction with RSPO Certification System (June 2017).
