Notification on RSPO Recertification Assessment of PT. Tunggal Yunus Estate – Topaz Mill and It Supply Base

PT. Inti Indosawit Subur (RSPO Membership number: 1-0022-06-000-00) has applied to PT SGS Indonesia to conduct RSPO P&C Recertification Assessment for one of their management Unit i.e. **PT. Tunggal Yunus Estate – Topaz Mill** and Supply Bases (RSPO Palm Trace number: RSPO_PO1000002142). This management unit holds valid RSPO P&C certificate SGS-RSPO/PC19-00023 until 29 March 2020.

The Recertification Assessment scope is **PT. Tunggal Yunus Estate – Topaz Mill and Supply Base**, 1 (one) Estate as supply base located at Petapahan Village, Tapung District, Kampar Regency, Riau Province, Indonesia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) 2018 in conjunction with RSPO Certification System (June 2017).
