**Cargill Incorporated (RSPO Membership number: 2-0215-11-000-00)** has applied to PT SGS Indonesia to conduct RSPO P&C Initial Assessment for one of their management Unit Kedipi Mill, PT Maya Agro Investama and Its Supply Bases (RSPO Palm Trace number: RSPO\_PO1000004853).

The initial Assessment scope is **Kedipi Mill PT MAI**, 1 (one) own Estate, 1 (one) Scheme smallholder as supply base located at Desa Silat, Kecamatan Manis Mata, Kabupaten Ketapang 78864, Kalimantan Barat – Indonesia against the requirement of RSPO P&C 2018 / National Interpretations for Indonesia (INANI April 2020), in conjunction with RSPO Certification System 2020 (November 2020).

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT SGS Indonesia has planned to conduct the assessment on 06 - 11 September 2021.
