Invitation to Comment on RSPO Certification Assessment of Sime Darby Plantation Sdn. Bhd. - Giram Oil Mill

Sime Darby Plantation Sdn. Bhd. has commissioned SIRIM QAS International Sdn. Bhd. for the assessment and certification of its certification units against National Interpretation of RSPO Principles and Criteria for Sustainable Palm Oil Production.

Sime Darby Plantation Sdn. Bhd. has applied to SIRIM QAS International Sdn. Bhd. for RSPO certification of nine out of its 59 certification units.
