The share of physical csPO has been risen since then continously. In 2013 August Storck KG sourced about 48 % of the total demand as csPO while the remaining 52 % has been covered by csPO/csPKO according to

the Book & Claim Model. In 2014 August Storck KG sourced approx. 75 % of its total demand as csPO/csPKO Mass Balance. The remaining 25 % has been covered by csPO/csPKO according to the Book & Claim Model. In the year 2015 August Storck KG sourced.
