The company is formed by independent estate to achieve for RSPO certification. Currently, there are total of 2,972.47Ha planted with oil palm. Chumporn Palm Oil Industry Public Company Limited is a member of RSPO since 15-Jun-2009 with RSPO membership number 1-0234-17-000-00.
