**Notification of RSPO Recertification-2 of Indrasakti POM PT Meganusa Intisawit subsidiary of Golden Agri Resources (RSPO Membership 1-0096-11-000-00, 31 March 2011)**

Dear Stakeholders,

Golden Agri Resources has applied to Mutuagung Lestari and will conduct Re-Certification at PT Meganusa Intisawit with scope Indrasakti POM and its supply based, located at Sungai Limau Village, Rakit Kulim Sub District, Indragiri Hulu District, Riau Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Indrasakti POM – PT Meganusa Intisawit has successfully been registered in the PalmTrace IT platform with member RSPO\_PO1000001065. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, 1 (one) estate, and 4 (four) smallholders on **04 – 08 September 2023**.
