Invitation to comment on RSPO Recertification cum Transfer Assessment of Kuala Lumpur Kepong Berhad (RSPO Membership No: 1-0014-04-000-00), Plantation Management Unit – KLK Batu Lintang POM & Estates, Kedah & Perak, Malaysia
