Invitation to comment on RSPO Initial Assessment of Felda Global Ventures Plantations (Malaysia) Sdn Bhd (RSPO Membership No: 1-0225-16-000-00), Plantation Management Unit – Kompleks Neram grouping, Kuantan (Pahang) & Kemaman (Terengganu), Malaysia
