Notification of RSPO Initial Certification of Bukit Makmur POM – PT Karya Makmur Bahagia subsidiary of Bumitama Agri Limited (RSPO membership number 1-0043-07-000-00 – 08 October 2007)

Dear Stakeholders,

Bumitama Agri Ltd has applied to PT Mutuagung Lestari for RSPO Initial Certification Bukit Makmur POM and its supply base, located in Village of Waringin Agung, Sub District of Antang Kalang, District of Kotawaringin Timur, Province of Kalimantan Tengah, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Bukit Makmur POM – PT Karya Makmur Bahagia has successfully been registered in the PalmTrace system with PalmTrace member ID is RSPO_PO1000005302. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to PT Karya Makmur Bahagia the organization which operating 1 (one) palm oil mill and 2 (two) estates on **05 to 09 July 2019**.
