Notification on RSPO Initial Certification Assessment (IC) of Arindo Trisejahtera POM – PT Arindo Trisejahtera - First Resources Limited

Dear Stakeholders,

PT Mutuagung Lestari will conduct Initial Certification Assessment at PT Arindo Trisejahtera (RSPO membership number 1-0047-08-00000) – Arindo Trisejahtera POM and its supply base, located in Rimba Beringin village, Tapung Hulu sub district, Kampar District, Riau Province, Indonesia against the requirement of the RSPO Standard i.e. Principles and Criteria of Roundtable on Sustainable Palm Oil, Generic Standard April 2013 and Supply Chain Requirement for CPO Mill, November 2014.

First Resources Limited has been taking an active role in the RSPO certification processes. PT Arindo Trisejahtera is implementing program to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment of PT Arindo Trisejahtera management unit which operating 1 (one) mill and 2 (two) estates on 03 to 06 June 2015

Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
