Notification on RSPO Re-certification of Mandau POM – PT Adei Plantation and Industry a subsidiary of Kuala Lumpur Kepong Bhd. (RSPO Membership: 1-0014-04-000-00)

Dear Stakeholders,

PT Adei Plantation and Industry – Kuala Lumpur Kepong Bhd. (RSPO Membership: 1-0014-04-000-00) – Mandau POM has applied to PT Mutuagung Lestari and will conduct Re-certification at Mandau Palm Oil Mill and its supply base, located in Muara Basung Village, Pinggir Sub-district, Bengkalis District, Riau Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Kuala Lumpur Kepong Bhd. is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. PT Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 6 (six) oil palm estates on **10th to 14th July, 2017**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification

- a. Environmental protection within the estate or mill including use of pesticide and waste management.
- b. Biodiversity within the estate and mill
- c. Contribution for local development and opportunities for employment
- d. Provision of housing, sanitation, facility and education support
- e. Other issues related with the assessment
