Notification on RSPO Recertification-1 Assessment of Blang Simpo POM – PT Perkasa Subur Sakti, PT Padang Palma Permai, PT Perkebunan Sri Kuala a subsidiary of Sime Darby Plantation Sdn. Bhd. (RSPO Membership: 1-0008-04-000-00– 7 September 2004)

Dear Stakeholders,

Sime Darby Plantation Sdn. Bhd. has applied to Mutuagung Lestari for RSPO annual surveillance to Blang Simpo POM – PT Perkasa Subur Sakti, PT Padang Palma Permai, PT Perkebunan Sri Kuala (RSPO membership number 1-0008-04-000-00) and its supply based, located in Village of Seuneubok Lapang, Sub district Peureulak Timur, District of Aceh Timur, Aceh Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Sime Darby Plantation Sdn. Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd. has been registered since September 7, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Blang Simpo POM – PT Perkasa Subur Sakti, PT Padang Palma Permai, PT Perkebunan Sri Kuala which has 1 (one) palm oil mill and 4 (four) oil palm estates on **23rd to 27th April 2018**.

- b. Biodiversity within the estate and mill
- c. Contribution for local development and opportunities for employment
- d. Provision of housing, sanitation, facility and education support
- e. Other issues related with the assessment


