**Public Notification on Upcoming RSPO Main Assessment of PT Perkebunan Nusantara III, Sei Meranti Palm Oil Mill, Rokan Hilir District, Riau Province, Indonesia.**

PT Perkebunan Nusantara III, Sei Meranti Palm Oil Mill (POM) has applied to PT TUV Rheinland Indonesia for main assessment of one of their holdings against the Roundtable of Sustainable Palm Oil Principles and Criteria.
