Invitation to comment on RSPO Certification Assessment of Minamas Plantation – SIME DARBY GROUP, Indonesia (PT Bhumireksa Nusa Sejati)

Dear Stakeholders,

Sime Darby Plantation Operation in Indonesia collectively called Plantation Upstream Indonesia. PT Minamas Gemilang and PT Anugerah Sumber Makmur managed the operation in Indonesia known as Minamas Plantation.

MINAMAS Plantation has applied to Mutuagung Lestari for assessment of PT Bhumireksa Nusa Sejati, located in Riau Province, Indonesia, against the requirement of The National Interpretation of Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO INA-NIWG, May 2008), Republic of Indonesia.

MINAMAS owned and operated 23 palm oil mills and 68 estates throughout Indonesia. The organization is a pioneer member of RSPO and has been taking an active role in the RSPO certification processes. MINAMAS Plantation is implementing program to achieve RSPO Certification for all operations by 31 December 2011.

Mutuagung Lestari has planned to conduct the proposed certification assessment of one palm oil mill and five estates on October 18th, 2010 – October 23th, 2010.

- Opportunities for earning fair wages, overtime and piece-rated work
- Opportunities for contracts and out-sourced work
- Provision of housing, sanitation, amenities and educational support
- Company relationship
- Any other topic / matters relevant to the assessment
