**Public Notification on Upcoming RSPO Initial Certification Assessment of PT Perkebunan Nusantara III Sei Baruhur Palm Oil Mill, Torgamba Village, Torgamba Sub-District, Labuhan Batu Selatan District, North Sumatera Province, Indonesia.**

PT Perkebunan Nusantara III Sei Baruhur Palm Oil Mill has applied to PT TUV Rheinland Indonesia for Initial Certification Assessment against Indonesian National Interpretation (INA-NI, 2016) of RSPO Principle and Criteria 2013 and the Roundtable of Sustainable Palm Oil (RSPO) Supply Chain Certification System standard year 2014. The Initial certification assessment shall be carried out by a qualified team of auditors to assess legal, environmental, economical, safety and social aspects as covered by the RSPO P&C.

PT Perkebunan Nusantara III Sei Baruhur Palm Oil Mill is a member of the RSPO (RSPO Membership Number: 1-0030-06-000-00) and has been actively involved in every international conference held by the RSPO.

**Scope of assessment:**

The RSPO Initial Certification assessment of PT PT Perkebunan Nusantara III Sei Baruhur Palm Oil Mill is scheduled to commence from **14 – 18 August 2017**. The assessment shall be carried out for 1 (One) palm oil mill and 2 (Two) palm oil plantations in Torgamba Village, Torgamba Sub-District, Labuhan Batu Selatan District, North Sumatera region. 
