Notification on RSPO Re-Certification Assessment of Sungai Buaya POM – PT Sumber Indah Perkasa a subsidiary of Golden Agri Resources Ltd (RSPO Membership Number 1-0096-11-000-00, 31 March 2004).

Dear Stakeholders,

Golden Agri Resources Ltd has applied to Mutuagung Lestari for RSPO Re-Certification to Sungai Buaya POM – PT Sumber Indah Perkasa and its supply based, located Talang Batu Village, Sub District of Mesuji Timur, District of Mesuji, Province of Lampung, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Golden Agri Resources Ltd has been taking an active role in the RSPO certification processes and implementing programme to continue RSPO certified Sustainable Palm Oil. PT Sumber Indah Perkasa – Sungai Buaya Mill has been registered on PalmTrace IT Platform with member ID RSPO_PO1000001342. Mutuagung Lestari has arranged to conduct the Re-Certification of PT Sumber Indah Perkasa which has 1 (one) mill and 3 (three) estates on **11 to 16 April 2019**.

Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.


