Notification on RSPO Re-Certification of POM 3 – PT Dharma Satya Nusantara (RSPO membership number 1-0135-12-000-00)

Dear Stakeholders,

PT Dharma Satya Nusantara has applied to PT Mutuagung Lestari for RSPO Recertification to POM 3 – PT Dharma Satya Nusantara and its supply bases, located in Village of Muara Wahau, Sub District of Muara Wahau, District of Kutai Timur, Province of Kalimantan Timur, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT Dharma Satya Nusantara has been taking an active role in the RSPO certification processes and implementing programme to continue RSPO certified. Dharma Satya Nusantara has been registered since 4 December 2012 as RSPO member. PT Mutuagung Lestari has arranged to conduct the Recertification of POM 3 – PT Dharma Satya Nusantara which has 1 (one) mill and 3 (three) estates on **14 to 18 January 2019**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
