Public Notification on upcoming RSPO Certification Assessment of Hap Seng Plantations Holdings Bhd. – Sg. Segama Group of Estates

Hap Seng Plantations Holdings Bhd. has commissioned TUV Rheinland Malaysia for the assessment and certification of one of their holdings in Lahad Datu, Malaysia and will be assessed against the Roundtable of Sustainable Palm Oil Principles and Criteria – Malaysian National Interpretation (MY-NI). The assessment shall be carried out by a qualified team of auditors to assess the legal, environmental, economic, health & safety and social aspects as covered by the RSPO P&C.

Hap Seng Plantations Holdings Bhd. is 51.55% owned (as at December 2009) by Hap Seng Consolidated Berhad, and was listed on the Main Board of Bursa Malaysia Securities Berhad on 16 November 2007. Hap Seng Consolidated Berhad is a progressive and well-established publicly listed company with diversified businesses in plantations, property investment and development, credit financing, trading of fertilizers and automotive, as well as building materials and stone quarries.

In line with RSPO certification requirements, Hap Seng Plantations Holdings Bhd. has established a challenging time bound plan to certify all its estates and mills in Malaysia by the year ending 2012.

Hap Seng Plantations Holding Bhd. announces Sg. Segama Group of Estates (SSGOE) under their subsidiary, Hap Seng Plantations (River Estates) Sdn. Bhd. to be assessed against the global RSPO standards framework. The group of estates is located at Lahad Datu, Sabah, Malaysia and consists of one mill with a capacity of 45 MT/hour and average annual output of 46,818 tonnes CPO. Fresh fruit bunches (FFB) to Bukit Mas Mill is supplied by 3 company owned estates covering a land area of 9,907 ha*.

Scope of assessment:

The RSPO certification assessment of Sg. Segama Group of Estates is scheduled to commence from 27 June – 1 July 2011. The assessment shall be carried out for 1 (one) palm oil mill and 3 (three) company-owned estates. The details of the oil palm mill and estates to be assessed are as follows:
