#### 9.2 How are you supporting them?

We,Äôre working with the Central Bank of Nigeria (CBN) and Heritage Bank to create access to finance for smallholders with verifiable land titles to invest in revitalising old and inefficient plantations.

As of January 2019, there are 1, 000 farmers registered and 2, 500 ha of farms have been mapped and geo-referenced to ensure they are in suitable locations.

Training has been delivered for the farmers who have organised themselves into registered cooperatives with clear leadership and governance structures.

We are also supporting 43 smallholder farmers, who together cultivate 150 ha of land, in the BPL sustainable outgower Scheme in Cross River State.

Social Impact Assessments including High Conservation Value assessments have been conducted and farmers supported to form co-operatives, open bank accounts and obtain legal land ownership documents, including Customary Rights of Occupancy.

Three out of four cooperatives have completed planting and we expect the fourth to be fully planted in May 2019.
