As a retailer, it can be challenging to ensure all vendors in scope of the policy have an adequate understanding of CSPO and all that it entails and are also engaged with RSPO in the ways necessary to adhere to Target's policy. Target continues its efforts to address these challenges through vendor trainings, individualized support, and online resources.
